# **GUIDING PRINCIPLES FOR LATER START TIMES (DRAFT):**

**Bruce Menin** asked the members to offer comments and/or things they would like to see reflected.

**Sean Reardon** thanked the people that worked on this. He really likes #4 - that we will find a way to do this and not give up.

**Nick deKanter** said we should come up with solutions for external concerns; find ways to schedule things so athletics and town level youth sports continue to be robust.

**David Hochheiser** said that finding solutions for sports is an external issue.

**Nick deKanter** would not include the "Examples of Solutions" section as part of the vote.

David Hochheiser stated he had no problem taking the "Examples of Solutions" section out.

**Nick deKanter** said he would be happy to accept #4 as a guiding principle if "external concerns" was changed, maybe talk about extracurricular programs.

**David Hochheiser** asked to <u>take out the word "external"</u> in #4.

Steve Cole agreed.

**David Hochheiser** stated the document we are voting on tonight is on the six principles minus the word "external"

**Steve Cole** asked if more narrative should be included in #1 so it is not just "improve academic and athletic success". Answer: <u>change wording in #1</u> to "*improve their overall success*" **Steve Cole** suggested that once approved, the Guiding Principles could be forwarded to the District Nurse Leader Cathy Riccio to share with the district's consultant physician.

## JLCF - LIFE THREATENING FOOD AND OTHER ALLERGY POLICY

**Sean Gallagher** introduced District Nurse Leader Cathy Riccio. He thanked Cathy and the nursing staff for all the hard work they've done over the years to create this allergy policy.

**Nick deKanter** reminded members that only the first page of the allergy package was the actual policy for the 2<sup>nd</sup> reading.

**Cathy Riccio** described the allergy policy and its contents.

**Sean Reardon** asked if there was any data on how many kids have allergies. Answer: The average is 2 students in a classroom have food allergies.

Nick deKanter asked what work is done to track dietary requirements/allergies of students.

Answer: Nurses, parents and café staff work together to share information. In addition, various trainings take place throughout the year.

**David Hochheiser** asked if there was any curriculum to teach other kids. Answer: Yes. The nursing team developed allergy appropriate curriculum this summer.

**Sean Reardon** asked if nut free tables would go away. Answer: No. Nut free tables will remain an option at the Bresnahan School, and parents will have the ability to opt out.

**David Hochheiser** asked if the liability would be on us if a parent opted out. Answer: No. It is actually a common practice in elementary schools.

**Bruce Menin** asked how the allergy policy and supporting materials would be distributed.

Answer: Upon approval, the materials will be sent home in the opening day packets.

**Brian Callahan** asked if schools can have year-end celebrations. Answer: This will be up to the building principals.

## **SUMMER FACILITIES PROJECT UPDATE:**

Director of Facilities Steve Bergholm reported on the following:

- <u>Custodial</u>: The entire staff have been working very hard and Steve is confident all buildings will be ready to welcome the kids back. The lead custodian at the middle school, Reyme Darling, retired after 34 years, which is a bit of a lost for the department.
- <u>Maintenance</u>: The crew has been very busy with a variety of work including plumbing, painting, and an extensive project which involved servicing the HVAC equipment.

- <u>Testing & Inspections</u>: Each summer testing/inspection of safety systems (i.e. fire alarms, kitchen hoods, sprinklers) is completed, which involves the Fire Department & Health Inspector. This year a preventive maintenance program with an outside contractor was added, which will include checking all kitchen equipment twice per year to ensure everything is operating properly.
- Projects: High School Robotics Storage Closet
  - Nock Gym Floor Strip and Refinish
  - High School & Bresnahan Gym Floor Screen and Recoat
  - Nock Water Heater Replacement
  - High School Front Walkway
  - High School Cupola: will not be completely done before school starts, but the scaffolding should be down.

**David Hochheiser** asked if there were pictures available; Answer = yes.

- High School Weight Room turned out very nice and the kids love it!
- <u>Solar Credits</u>: Steve would like permission to participate again in this solar credit program to save an additional \$15,000 on the electric bill.

On a motion by **Sean Reardon** and seconded by **David Hochheiser** it was **VOTED:** To approve participating again in the Solar Credits program.

# <u>DISCUSSION OF THE CITY OF NEWBURYPORT HOME RULE CHARTER REVIEW</u> <u>PROCESS</u>

**Bruce Menin** said the Charter Review Committee is supposed to meet in September. One topic that does come up is questions about the Mayor being on the School Committee.

**Nick deKanter** says it is worth talking about. We are lucky to have a Mayor who is interested in our schools, regularly attends meetings, is always prepared etc.

**Steve Cole** described how the Charter Committee is made up.

**David Hochheiser** said that term lengths for SC are written in the Charter, and feels 4 year terms may be a lot to ask. Would more people run if the term was 2 years like City Council? There is also a clause in the Charter that School Committee members cannot hold city positions within the year after leaving the School Committee. Members are not allowed to apply for school based or City positions, but City Counselors are.

**David Hochheiser** stated communication about the City Charter process should be written in the Charter. Could we have this discussion at a working School Committee meeting?

Bruce Menin will talk to Superintendent Sean Gallagher.

Superintendent Gallagher reported on the following:

**Sean Reardon** stated he would be in favor of voting in those on the waiting list if it remained only 3.

**Bruce Menin** stated there isn't a SC meeting prior to school starting so maybe we should vote to give the Superintendent the ability to accept more if needed.

**Sean Gallagher** will obtain an accurate number on enrollments, as well as data on students moving to/from private schools.

On a motion by **Nick deKanter** and seconded by **Sean Reardon** it was **VOTED:** To authorize the Superintendent to add three more grade 9 school choice spots in the high school if needed.
