Student Representative Report

Theo Roberts presented the student report which included ELA MCAS at the Bresnahan, state postcard race at the Molin, and congratulations to the high school's RWDC Team for their 3rd place win at the national competition. (attached)

Newburyport Reps – Whittier School Committee Check-in

Mary DeLai attended her first meeting on April 10th. The proposed FY25 budget was approved and Newburyport's increase was 10.07%, the SOI was submitted, and Whittier is looking into building project possibilities with NECCO. Brett Murphy reported school was closed April 2nd due to problems with a water hydrant and delayed April 4th due to weather. Juniors attended a Credit for Life Fair, two Newburyport students were participating in the upcoming Skills USA event, and 35 co-op employers in Newburyport were employing 81 Whittier students.

FY25 NPS Budget

- Superintendent Gallagher presented the final proposal for the FY25 Budget, which included a review of three new options for the City Appropriation: 4.74%, 4.5% and 4.25%. Phil Littlehale explained how funds in School Choice and Revolving accounts would be used to cover the increased expenses in the new scenarios.
- Brian Callahan suggested City budget discussions with the district should begin in November at the Joint meeting.
- The Use of Fund by Cost Center information was incorrect on page 1, therefore the vote was withdrawn.
- A "special" School Committee meeting will be held at 6:00PM on Monday, April 29th to review the corrected Cost Center information and vote on the proposed FY25 NPS Budget.

VOTED: to accept the 4.5% version of the City Appropriation for the FY25 Budget (with an overall 2.99%) in accordance with Policy DBG – Budget Adoption Procedures.

CREST Collaborative Capital Fund Increase Request

The CREST BOD recently approved several initiatives, and needs to increase the capital fund limit. Newburyport is one of sixteen CREST member districts. Approval by two-thirds of the member districts is required to revise the capital plan fund.

- Open Positions: Eight people were interviewed in the first round for the Facilities Director position and there are two finalists. The two Special Education Program Supervisor positions were advertised. The posting for the Assistant Superintendent of Teaching & Learning position is now closed.
- Grants Update: (1) The district was designated for a \$75K Environmental & Life Science Pathways grant in FY25, and \$50K for the next four years. Two other pathways are being reviewed (2) District is now eligible for a DESE Capital Skills grant (3) District was approved again for the Afghan Refugee Support grant - \$126K and (4) the district will hold their first meeting this week to review the Green Light Grant, as well as (5) look into a few clean energy and mental health grants.

Bresnahan Elementary School:

The Bresnahan is also celebrating National Mathematics and Statistics Awareness Month. This was started in 1986 to help increase interest, appreciation and understanding of the field. Students will have weekly estimation challenges, biweekly math riddles, and a math spirit week. Thank you to our math coach, Molly Farrell, for organizing this fun school-wide event!

Edward Molin Upper Elementary/Rupert Nock Middle Schools:

5th graders are learning about the hydrologic Cycle, water sources, and discussing the human impact of runoff from roads, business and home properties, and agriculture. They will be touring the wastewater treatment plant, water treatment plant, the Little River Nature Trail and Maplecrest Farm with presentations by staff at each location.

Also, 4th graders are in the middle of their yearly State Postcard Race, in which each class attempts to collect as many postcards from all 50 states as possible.

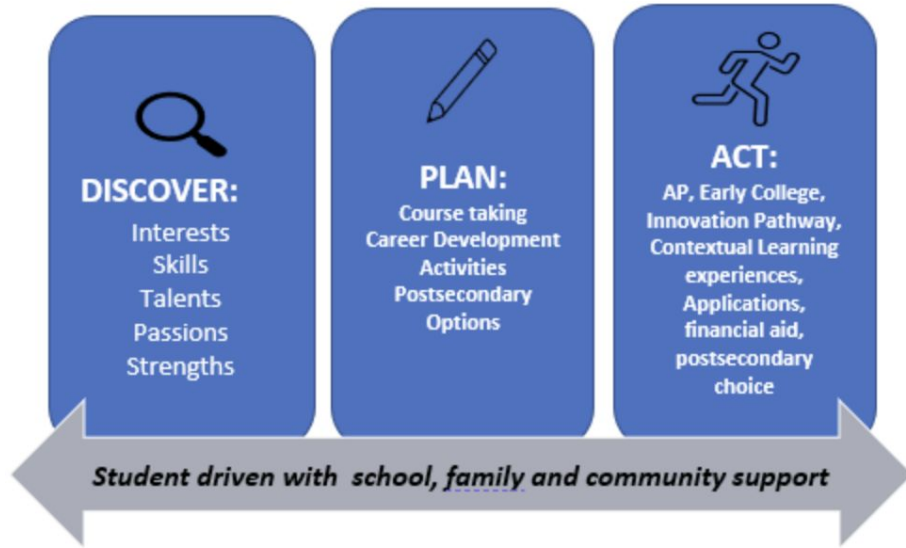
INNOVATION CAREER PATHWAYS

Launched in 2017, Innovation Pathways are designed to create strong partnerships with employers to expose students to career options, and help them develop knowledge and skills related to a particular field before they graduate high school.

"It is incumbent upon us to do everything we can to ensure our students are ready to succeed in the 21st Century economy, and these new career pathways are one example of the work that is going on in our schools to do that." --- Governor Charlie Baker

Innovation Pathways provide students in **traditional high schools** with career-oriented education that is too rarely available outside of vocational programs, according to **Education Secretary James Peyser**. These new pathways don't train students for specific occupations, but prepare them for a variety of educational and career opportunities in a broad industry or sector.

My Career and Academic Plan (MyCAP) prepares students for college, career and civic readiness. MYCAP works to:



- Engage students in authentic postsecondary planning focused on the individual student's interests, skills and talents.
- Empower students to be the drivers of their education and connect their course taking with career interests
- Help students to seek out career development opportunities such as internships, apprenticeships, capstone projects
- Allows students to identify the personal, social, and behavioral skills needed to be successful in the workplace.


Diving Deeper

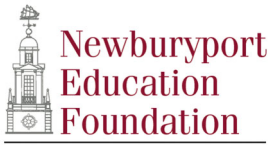

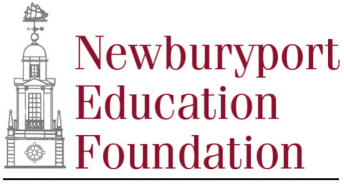

FF - Naming New Facilities

Naming New Facilities

Naming a school facility is an important matter that deserves thoughtful attention. Personal prejudice or favoritism, political pressure, or temporary popularity should not be an influence in choosing a name for a school, a portion of a school, or a portion of school grounds. Whenever possible, the wishes of the community, including parents and students, should be considered in naming school facilities.

The School Committee has the authority to approve the naming and renaming of buildings, structures, and facilities located on school property. The School Committee also has the authority to name subsections of existing structures or facilities, such as classrooms, auditoriums, and gymnasiums. The School Committee may elect to authorize the designation of naming rights for specific portions of our facilities to the Newburyport Education Foundation through advanced approval of a list of naming opportunities to be reviewed annually.

Names and/or wording associated with school facilities shall be consistent with school district policies and promote messages aligned with the mission, vision and goals of the school district. To the extent possible, names and/or wording should be designed not to restrict the use of a space or inhibit changing the function of the space should that become necessary in the future.

When the opportunity to name or dedicate a new school or school related property, structure or facility is forthcoming, an orderly procedure will be communicated at the next available School Committee meeting. The Committee's agendas should clearly reflect the intent to consider, review, and vote on naming opportunities.

Submission of a name for a school space may be made by any resident or by the Superintendent, in writing, and should be made to the School Committee Chair. If a name is being initiated at the local school level, the Principal must take reasonable steps to include the School Council and PTO in the nomination of the name before submission to the School Committee.

The written request should specify the intent of the requestor and the reasons why this particular name would fit the facility. It should offer appropriate background information on the person or organization after which the facility will be named. An offer of a financial contribution to the School District may accompany the naming request, but the School Committee is not obligated to accept or reject a name based upon financial considerations alone. Philanthropic contributions in support of the School District are encouraged by the School Committee. The School Committee may acknowledge generous donors by designating appropriate spaces within the School District's facilities consistent with the level of financial commitment.

Following the submission of a naming request, the School Committee Chair will specify a consideration period that allows for public comment, following which the Committee will deliberate and vote on the name.

BE - School Committee Meetings

Adoption Date: 09/06/2016

The School Committee will transact all business at official meetings of the Committee. These may be either regular or special meetings, defined as follows:

1.

Regular meeting: the usual official legal action meeting, held regularly

2.

Special meeting: an official legal action meeting called between scheduled regular meetings to consider specific topics

Every meeting of the School Committee, regular or special, will be open to the public unless an executive session is held in accordance with state law.

Meetings

a.

The School Committee will meet on the first Monday of each month from August through June. The Committee will meet on the third Monday of the month, except in the month of July. The Committee shall set a standard start time and location for these meetings during the first meeting of each new year. The Committee may, by a majority vote, and for good reason, change the date, place or time of the regular meeting.

b.

Special meetings will be scheduled when called by the Chairperson and/or their designee, requested by two or more members, or collectively agreed upon by a majority of the committee as the result of a discussion during a regular meeting or an executive session. The need for timeliness for such a meeting will be recognized when it's scheduled. The notice of the special meeting shall state the reason for the meeting and shall be transmitted to each member and to the City Clerk at least two (2) business days, excluding weekends and holidays, prior to the time of the meeting.

c.

The Committee may, by a majority vote of those present, there being a quorum, adjourn any meeting to another date and time, and such meeting shall be deemed a continuation of the present meeting. The meeting shall be posted in the office of the City Clerk at least two (2) business days, excluding weekends and holidays, prior to the time of the meeting.

d.

The Committee may, by a majority vote, conduct a public hearing to ascertain public opinion on a subject that is before the Committee and shall, in any case, conduct a public hearing on the school budget in accordance with the law. The Committee shall set the date, time, and place of such public hearing and shall establish rules for the conduct of such hearing.

e.

The Committee may meet from time to time for the purpose of receiving information and discussing matters pertaining to the educational program of the schools. Any such session shall be posted in the office of the City Clerk at least two (2) business days, excluding weekends and holidays, prior to the time of the meeting.

f.

Any duly-called meeting of the Committee may, for good and sufficient reason, be canceled or postponed by the Chairperson or the Vice-Chairperson. When the Chairperson or the Vice-Chairperson cancels or postpones a meeting, they shall inform the Superintendent, whose responsibility it shall be to notify the members.
